1. Tenderers are strongly advised to go through all the documents in connection with this tender very carefully. The tender document and schedule of quantities and specifications can be purchased on cash payment of Rs. 1000/- (Non refundable) on any working day from 10 AM to 5 PM from the office of National Horticultural Research & Development Foundation, Chitegaon Phata, Nashik-Aurangabad Road, Post-Darna Sangvi, Taluka- Niphad, Nashik-422 003 (Maharashtra) or print will be taken from the website: [www.nhrdf.org](http://www.nhrdf.org)
2. The **CRMs** are covered under tender.
3. The shortage, breakdown in transit will be the sole responsibility of the supplier and the same will be intimated to the supplier on receipt of **CRMs** by the purchaser to make good the loss caused on this account. The defective supply will have to be replaced by the supplier within stipulated time without freight/transport charge.
4. The **CRMs** shall be delivered at our lab located at National Horticultural Research & Development Foundation, Chitegaon Phata, Nashik Aurangabad Road, Post-Darna Sangvi, Taluka- Niphad, Distt. Nashik-422 003 (Maharashtra).
5. Goods & Service Tax (GST) as per Govt. rules will be paid extra as applicable.
6. The Competent Authority may grant extension of supply time for valid reason if the supplier approaches immediately after receiving the purchase order.
7. The payment of the bill will be made within 30 days on receipt of the **CRMs** in satisfactory condition.
8. No revision in rate (on higher side) will be accepted after finalization of rates.
9. The order will be placed as per requirement irrespective of the value of the order.
10. The firm would supply the required **CRMs** as per unit price mentioned in the price list/tender.
11. The dispute arising between CRM producer/supplier (compliance of ISO-17034) and the purchaser will be referred to Arbitrator appointed by the CEO, NHRDF for which sole arbitration and decision there on will be binding upon both the parties.
12. Supply should be made in full against the purchase order and shortage will be procured on the risk and cost of the supplier.
13. No payment will be made for unsatisfactory supply of **CRMs**.

14. **CRMs should a longer expiry (min 3 years) period & should be supplied in original packs.**
15. **Certificate of Analysis (COA) must be provided for each CRM at the time of delivery to the laboratory.**
16. **The CRM manufacturer must ensure compliance with ISO 17034.**
17. **The tenderer must quote the price of CRM for make of Dr. Ehrenstorfer (Germany) and Sigma brands.**
18. Two copies of bills / invoice should be submitted alongwith **CRMs delivery.**
